INTRODUCTION

The City of Lanesboro is considering a street & utility improvements for construction in 2017. The City has prepared preliminary information about the scope of the project along with estimated costs. The specific streets proposed for improvements include:

- Auburn Avenue South – Between Whittier Street East and Zenith Street
- Circle Drive – Between Auburn Avenue South and its eastern terminus
- Zenith Street – Auburn Avenue South and the eastern intersection of Maple Drive

PUBLIC INPUT

Two opportunities for public input are planned. A Neighborhood Informational meeting is planned for **Thursday, August 25th at 6pm** at City Hall and a Public Hearing is planned for **Monday, September 6th at 5:30pm** at City Hall to provide the public with information about the proposed project and to gather input.

The Neighborhood Informational Meeting is an informal meeting where residents will have an opportunity to hear a presentation on the project, ask questions, and provide input. The Public Hearing is a formal City Council meeting where residents will have the opportunity to ask questions and provide input to the City Council.

ESTIMATED PROJECT COSTS

Street Improvements - \$1,389,988
Storm Sewer Improvements - \$638,007
Sanitary Sewer Improvements - \$265,621
Watermain Improvements - \$81,484
Total Project Cost - \$2,375,100

PROJECT FUNDING

The project will be financed in part through special assessments levied against the properties abutting the improvement. Specific information about the proposed special assessments will be available at both the Neighborhood Informational Meeting and at the Public Hearing.
