Regular Meeting Minutes

A discussion was held about the penalty and the desire to have stepped warnings, as well as clear exceptions. A motion was made to table the item and request the Administrator to recommend a list of exceptions, and penalty tiers by Member Levine and seconded by Member Seiler. Motion carried all in favor.
- B. Consider SolSmart Certification:** Member Pearson shared that this helps communities be solar friendly, is a free service and has some grant eligibility opportunities. Member Pearson made a motion
